1. Scope

Asthma is a condition which affects a range of individuals including pupils, staff and volunteers across the Academy to different extents. Appropriate care is essential to ensure the health and safety of all those diagnosed with asthma.

2. Aim:

This policy contains the guidance and procedures to be followed when caring for pupils with asthma to ensure:

- Full participation in all aspects of school life and reduced absence
- Staff have a clear understanding of the procedures to follow in the event of a child having an asthma attack
- To ensure immediate access to inhalers
- To keep accurate records of children's medication
- Adherence to the current guidance on use of emergency salbutamol inhalers in schools.

This policy also contains guidance for adults with asthma.

3. Medications and inhalers

There are two types of treatment both of which come in an inhaler.

Preventers - These inhalers are taken daily to make the airways less sensitive to individual asthma triggers. They are usually taken morning and night. They usually come in brown containers. These inhalers are not used or kept in school.

Relievers - These inhalers quickly open up the narrowed airways and help the individuals breathing difficulties. They usually come in blue containers. Children's inhalers are stored in asthma boxes in the classroom. Adults are responsible for storage of their own inhalers.

All inhalers should be taken through a a spacer, into which the aerosol is released.

Every pupil diagnosed with asthma should have one prescribed reliever inhaler and spacer in school before the pupil begins attending. This is kept in the classroom. It is essential that all pupils with asthma are allowed to access their reliever inhaler freely at all times.

In classroom reliever inhalers are kept in boxes. Each inhaler is labelled with the child's name. If the inhaler is used this should be recorded on CPOMS and the Welfare room must be advised. Inhaler boxes should be taken to all activities the children participate in.

Staff in Breakfast Club would use the nearest emergency pack.

4. Administering Medication

Every pupil is encouraged to administer their inhaler without any help under the supervision of an adult.

Some pupils need to use their reliever inhalers before exercise. Class teachers and the PE teacher are informed, the inhaler is administered and administration is recorded on CPOMS.

A member of staff will monitor the child while they take their inhaler and log on CPOMS.

Staff receive asthma advice on a yearly basis from the School Nurse. Asthma posters are in every asthma box and displayed around the school. These are updated yearly if required.

Parents/carers will be advised by text whenever their child uses their inhaler.

5. Parental responsibilities

Parents are responsible for providing the school with one prescribed inhaler and a spacer for their child.

It is the parent's responsibility to replace any out of date medication as soon as they are notified of its expiry.

Parents are also required to keep the school informed about any changes in their child's asthma or care plan.

Every parent signs a parental consent form giving permission for the reliever inhaler to be used and an emergency salbutamol inhaler administered, if necessary.

6. Emergency Inhalers

Emergency Salbutamol inhalers will provide medication in an emergency only for:

- Pupils who have been prescribed a salbutamol reliever inhaler and have written parent/carer consent
- Adults who have been prescribed a salbutamol reliever inhaler.

Emergency inhalers are kept in: Nursery, Welfare, EYFS (Fridge)), Staffroom and the Dining Hall.

Each pack contains:

- 2 x Inhaler
- 2 x Spacer
- List of pupils with consent.

In the event of an emergency, and the child's own inhaler not being available/usable, staff should use the nearest emergency pack. When an emergency asthma pack is used Welfare must be notified immediately. They will then remove and replace the spacer. The used spacer must be washed thoroughly with soap and warm water before being made available for future use.

7. Advice and Support

If further help is required with regards to the management of a pupil's asthma to prevent it impacting on access to education advice should be sought from the School Nurse via Welfare.

Inhaler usage is shared with Hillingdon Hospital on a monthly basis to support health service with identifying children whose asthma requires review.

8. Adults with Asthma

Adults with asthma are responsible for ensuring they have access to a prescribed inhaler and spacer whilst on the school site.

Adults with asthma should be aware of any triggers for their asthma and ensure appropriate actions are taken to mitigate any risks. Where a particular risk is identified adults should ensure the Welfare officer is aware of this.

Is advised that adults with asthma declare this on their medical form and give it to the welfare officer.

9. Equal Opportunities

At Charville Academy we recognise the need to ensure individuals with asthma have equal opportunities across all school-based activities.

SIGNS OF:

WHEEZING

COUGHING

SHORTNESS OF BREATH

TREATMENT:

GIVE RELIEVER (**BLUE**) INHALER – **2** PUFFS

(USE A SPACER IF IT IS THIS TYPE OF INHALER)



IF NO OR MINIMAL EFFECT

GIVE UP TO **10** PUFFS OF RELIEVER (**BLUE**) INHALER

If better (symptoms resolved)

Inform parents & advise

GP appointment

If little or no improvement:

DIAL 999

Continue to give **BLUE** (reliever)

inhaler **10** PUFFS every **10**
minutes

until medical help arrives or

symptoms improve.
